1. Introduction

2. Key Dates & Booking

- **Booking Period:** From 6th May 2025
- Travel Dates: Guests must be staying at Club Med La Palmyre Atlantique for any dates between 25th October and 1st November 2025

The Wolves FC Football Camp is an **included activity** during the week and does **not alter or affect your booking**. Customers are purchasing an all-inclusive Club Med holiday, with the Football Camp offered as an optional value-added experience.

3. Wolves FC Football Sessions

A limited number of football training sessions with **Wolves FC coaches** will be offered during the Program Dates.

- Sessions are open to children and teens aged 4 to 17 years old
- Participation is subject to availability, and offered on a first-come, first-served basis
- Reservation is not guaranteed with your accommodation booking
- A session registration form will be provided post-booking
- Last-minute registrations may be available in-resort, depending on availability

Club Med shall be responsible for **facilitating all participant registration**, including obtaining the necessary **consents**, **waivers**, **and release forms**, including permission related to **photography/filming**.

Specific **session times and groupings** will be confirmed in the weeks prior to the event, based on the number of registered participants. This includes the **maximum number of attendees**, session **structure**, and overall **camp itinerary**.

Club Med **shall not charge separately** for Football Camp participation. These sessions are included in the **Club Med all-inclusive package** for La Palmyre Atlantique during the applicable dates.

Club Med reserves the right to amend the schedule, structure, or format of the sessions at its discretion.

- Daily gourmet meals & all-day snacking
- Open bar with wine, beer & cocktails
- Access to sports & resort activities (excluding à la carte)

7. Cancellation & Force Majeure

The **standard Club Med cancellation policy** applies to all bookings.

If the Football Camp is altered, postponed, or cancelled due to unforeseen circumstances, including but not limited to **force majeure**, guests' holiday bookings will **not be affected**. The Football Camp is an included, optional activity and not a standalone paid service.

Club Med reserves the right to cancel or reschedule the Football Camp in the event of circumstances beyond its control, such as extreme weather, coach illness, or operational limitations or force majeure with Wolverhampton Football Club. No compensation will be due as long as the primary holiday is delivered as booked per Club Med's booking conditions.
